## **Analysis Overview**

The book, Permission to Walk in Peace, was uploaded to several websites to assess the copyright, plagiarism, Al generated text and similarity to other published works made available on the internet. The objective was to clearly state that copyright, proper attribution and original content was established by the authors. This document contains the results from five public Al tools, one content specific tool and one proprietary tool

#### 1. GROK

The manuscript "Permission to Walk in Peace: Stories of Healing from Trauma as Told by Combat Veterans," edited by G. Craige Edgerton, is highly likely to be original content due to its context-specific writings. Comprising personal narratives, poems, and essays from combat veterans, the document reflects unique, firsthand experiences of trauma and recovery, primarily from the Vietnam War and other conflicts.

Each contributor's distinct voice and perspective, such as Jim Marney-Petix's vivid recounting of a mortar raid or Bill Noyes's translation of a battlefield letter, are deeply personal and tied to specific events, making verbatim copying from external sources improbable. The only quoted materials, from Dwight Eisenhower and Doug Rawlings, are properly attributed, further supporting the originality of the work.

#### 2. META

The text appears to be a collection of poems, stories, and writings from a book titled "Permission to Walk in Peace: Stories of Healing from Trauma as Told by Combat Veterans." The book is copyrighted by G. Craige Edgerton, Editor, and published by ALIVE Book Publishing.

Given the nature of the content, it seems that the authors are sharing their personal experiences and stories, which may be original works. The copyright notice is clear, and the publisher has taken steps to protect the intellectual property rights of the authors and editor.

Varied Writing Styles: The document contains a collection of works from different authors. As stated in the introduction, "The writing styles reflect that artistic endeavor with poems, essays, and stories". This inherent variation in style is expected in a compilation of personal narratives and might make it difficult to assess the presence of a single, uniform AI voice.

**Personal Narratives**: The core of the document is veteran's personal experiences with trauma. These types of texts are often characterized by individual voice, specific word choices, and emotional expression, all of which are less likely to be uniformly replicated by AI.

**Specific Details**: Many of the narratives include very specific details, such as locations, names, and dates (e.g., "March or April 1968", "Highway 9", "Firebase Fuller" ). The presence of such specific information could indicate human authorship, as AI-generated text might sometimes be more general.

#### 5. PERPLEXITY

#### 6. SCRIBBR

The Al-Generated Content And Plagiarism Checker functionality was utilized for the analysis. According to Scribbr, the document was compared to the world's largest content database, covering 99.3 billion web pages, 8 million publications and over 20 languages. The following is the Al-Generated summary of the document analysis:



**SUMMARY:** The output was limited to the Al-Generated Content review which highlights that less than 2% of the text was a combined human written with Al refinement. Overall, the document is human written.


